





# Apprenticeship Standard for Adult Care Worker Level 2

### **Occupational profile**

Adult Care Workers are the frontline staff who help adults with care and support needs to achieve their personal goals and live as independently and safely as possible, enabling them to have control and choice in their lives.

#### **Responsibilities**

To work in care is to make a positive difference to someone's life when they are faced with physical, practical, social, emotional or intellectual challenges. Adult Care Workers need to have the right values and behaviours developing competences and skills to provide high quality compassionate care and support.

They are the frontline staff who help adults with care and support needs to achieve their personal goals and live as independently and safely as possible, enabling them to have control and choice in their lives which is at the heart of person centred care.

Job roles are varied and determined by and relevant to the type of the service being provided and the person supported. Adult Care Workers may work in residential or nursing homes, domiciliary care, day centres, a person's own home or some clinical healthcare settings.

Job titles might include: Care Assistant, Care Worker, Support Worker, Personal Assistant, Relief Team Worker, Support Worker - Supported Living, Key Worker in Residential Settings, Key Worker in Domiciliary Services, Key Worker in Day Services, Home Care Support Worker, Substance Misuse Worker, Learning Disability Support Worker, Mental Health Support Worker, Mental Health Outreach Worker and Re-enablement Worker.

#### **Entry Requirements**

The entry requirement for this apprenticeship will be decided by each employer. Candidates must undertake a recognised enhanced disclosure and barring service check and be at least 16 years of age.

	<ul> <li>There is a vast amount of optional units for you to choose from. Entry requirements	You should be at least 16 years old.
	It is a requirement to undergo an enhanced Disclosure and Barring Service (DBS) check. Employed in a related job role preferably for at least 30 hours/week. Can be working for less hrs but will extend the length of time on programme. Minimum hrs allowed is 25.
Who is it for?	Learners new to the care industry or experienced with no formal qualifications.
Cost	<ul> <li>Total apprenticeship cost: £4,000</li> <li>If you are a Levy payer, this will come out of your Levy account. If you are a non levy payer, the government via the ESFA will pay 95% of the programme and the remaining 5% will be paid by you within the first 3 months of the programme.</li> <li>As of 1st April 2024, if your learner is aged 21 or under and you are a non levy employer that is classed as a small or medium sized business, the government will pay for the remaining 5% co investment.</li> <li>If your learner is 16-18, your company will receive an incentive payment of £1000 which is paid in two instalments to support the learning programme.</li> <li>There is no cost to the apprentice.</li> </ul>
Duration	14 months
Start date	Available throughout the year
Assessment method	<ul> <li>Work Based Evidence, Direct Observation by Assessor, Witness evidence, professional discussion, reflection on own practice, written assignments, learners own work products.</li> <li>Your qualification will be delivered through a combination of monthly online teaching sessions, one-to-one support sessions with your tutor, 10-12 weekly progress reviews, monthly assignments, research, observations in the workplace and using our online learning platform to be able to access further training materials to aid your learning.</li> </ul>
